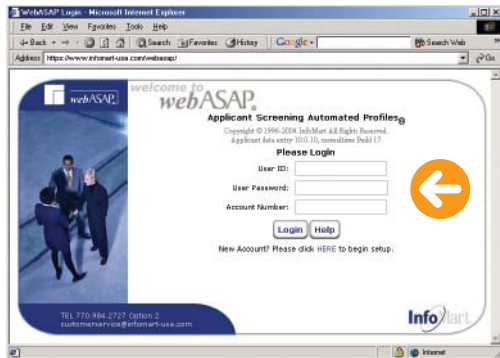

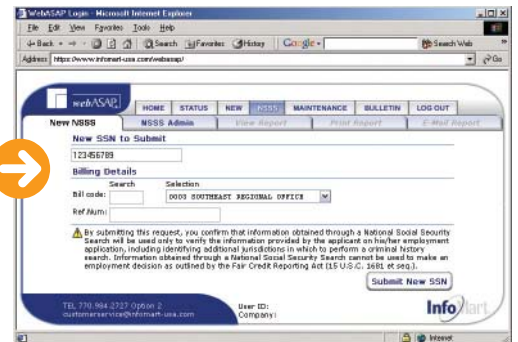
- Go to <https://www.infomart-usa.com/webasap/>

2 enter a request

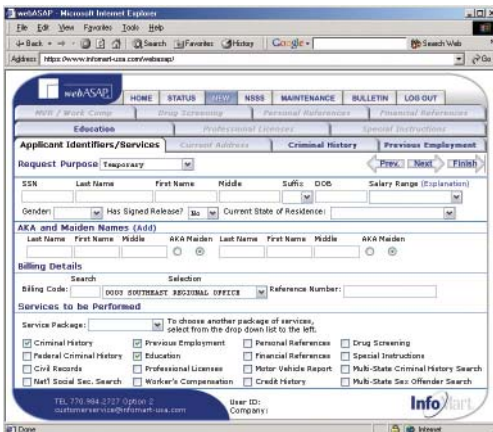
enter a request

- Click on the “NSSS” tab on the top menu bar.
- Enter the 9-digit SSN (no spaces or dashes) in the “New SSN to Submit” field.
- Click the “Submit New SSN” button; the SSN report will return in 3-5 seconds.



3 order services

- At the “Applicant Identifiers/Services” tab, fill in all required fields, including Signed Release, Current State of Residence, Billing Code and Services (if not pre-selected).
- Click the “Next” arrow to continue.



- Continue through each service tab (Criminal, Employment, etc.), entering applicant data and clicking the “Next” arrow until complete.
- See the “WebASAP User Guide” for more details on how to enter data in each service area.

4 complete the request

complete the request

- Click the “Finish” button.
- WebASAP will check for errors and omissions and take you to the confirmation page.
- If errors are found, you will be required to “Make Corrections.”
- If no errors are found, click the “Submit” button.
- Your request is complete and may be viewed on the Status page.

5 view profile

- Go to the “Status” tab to see a list of all pending and completed requests.
- To view a profile, click on the applicant name and then click “View Profile.”
- If your company has set-up hiring criteria, the “Flag” column will indicate if the applicant meets or does not meet the criteria.

National Social Security Search InfoMart will conduct an identity verification and fraud search matching the Social Security Number to the issued name. Employment Verification A previous employment verification can provide you with key information about an applicant's work history, productivity, and overall work ethic. Former employers are valuable sources when compiling a complete profile on your applicant. Education Verification Education is the most commonly falsified information provided on an application.
